- * Pageant is open to residents and nonresidents of Tazewell County
- * Practices are listed below with all categories. It is very important that everyone be at this practice. You will receive your number and be updated on any possible time schedule changes that might need to be made.
- * There is a \$25.00 entry fee for all contestants. This may be paid by one sponsor and must be for the exact amount of entry fee. The last day to enter the pageant without a \$15.00 late fee is JULY 17, 2006. We will NOT accept any entries after July 30, 2006. You must be registered before your practice time starts. NO EXCEPTIONS. One parent must accompany each contestant on stage. The entry fee will also include one free 10 X 13 canvas photo of the contestant.
- * A photographer will be available to take package pictures. No one will be allowed to take photos at or around the photographer's area. THIS IS PROHIBITED.
- * There will be a Queen and three runners-up in each age division. The winners will receive a large crown, trophy, banner and \$50.00 cash. Runners-up will receive a trophy. All other contestants will also receive a trophy.
- * Pageant attire is requested but not required. The score sheets do list choice of attire. Professional pageant judges will be employed.
- * All proceeds go to the Tazewell County Fair Association.
- * Last year's Queens are invited to return and crown their age division but will not be allowed to re-compete this year.
- * Age is determined as of the day of the pageant. NO EXCEPTIONS.
- * If a Queen or King choose to be in a parade, they are responsible for obtaining their own transportation, making their own sign and notifying the fair coordinator of their intentions to ride in the parade.
- * If any pay is offered for any appearances, whether it be a flat fee, mileage, etc., all negotiations will be handled by the fair office.
